A Contract for Entertainment Services

- 1) The performer agrees to provide magical and/or other related entertainment services as described below for the period identified above.
- 2) The performer agrees to provide additional services, limited to the specific description provided below by the client.
- 3) The performer agrees to provide services only on the designated dates above and for the specified period of time.
- 4) The performer agrees to arrive at a time appropriate for any required set-up at no additional charge to the client.
- 5) The performer agrees to strike the performance set and props within a period of time sufficient to clear the area without damage to the materials or show place.
- 6) The performer reserves the right to suspend set-up and performance activities if he or she deems, for any reason, that the circumstances are not suitable for the quality of the show, security of the show props and/or performers, or for any other reason that the performer may experience that might impede the successful delivery of the contracted services.
- 7) The client agrees to pay the full fee for the contracted performance upon the arrival of the performer in cash, check, or money order.
- 8) The client agrees to provide the performer adequate time on location of the performance for setting up and striking the props and materials for the show.
- 9) The client agrees to notify the performer no later than 48 hours in advance of a performance of an intention to cancel the contracted entertainment services. (Not negotiable)
- 10) The client agrees to pay 50% of the contracted fee for entertainment services if notification of an intention to cancel a contracted performance is made within 48 hours of the scheduled performance. (Not negotiable)
- 11) For performances outside of Dallas County, the client agrees to pay travel expenses of \$.48 per mile/air transportation/overnight accommodations for one night (if applicable) and a \$50 per diem for each 24 hour period. (Not negotiable)
- 12) For private parties the client agrees to pay \$150 per hour, \$150 minimum, \$50 per half hour above the minimum fee for each additional half hour. The client agrees that any performance extending into a new half hour will engage the full one-half hour fee. (Not negotiable)
